## Course ordinance for B. Pharm Including scheme of examination and course curriculum

Eligibility of admission: The minimum qualification for admission to B. Pharm semester-I shall be:

## 1. Minimum qualification:

50% marks in any of the following examination with physics, chemistry & Biology or Mathematics:

- (i) Intermediate examination in Science
- (ii) The first year of three years degree course in science
- (iii) 10 + 2 examination (Academic steam) in science
- (iv) pre-degree examination
- (iv) Any other qualification approved by the pharmacy council of India as equivalent to any of the above examination
- 2. Medium: Medium of Instructions and Examination shall be of English
- 3. Method of Teaching: Method of teaching in the academic programme will consist of class lecturers by the regular faculty, in-house visiting faculty and the visiting faculty from other academic and practicing organization/Institutions. Tutorials, Seminars, Industrial visit (after B. Pharm Semester VI) and submit the industrial visit report to the institute) and cases studies shall be essential component of curriculum. Quality study materials will also be supplied besides computer-aided-Institutions and audiovisual teaching methods. Educational tours to the practicing organization in the field shall be conducted
- 4. Duration of Course: Duration of course shall be for four academic years in eight semesters. Each semester shall have teaching not less than ninety (90) to one hundred five (105) working days. In addition, practical training not less than four hundred hours (400) speared over a period of not less than two months shall be undertaken by each student after the completion of semester VIII.
- 5. Examination: There shall be an examination for B. Pharm semester course in every six month. The one will be held around December which shall be the main examination for odd semesters. The second will be held around May which shall be the main examination for even semesters. For semester system there shall not be any supplementary examination except for the final semester students. The examination shall be of written and practical nature carrying maximum marks for each part of a subject as indicate in the table No. 1 to table No. 8
- 6. Eligibility for appearing at the B. Pharm Semester examination: only such candidates who produce certificate from the HOD of the institution or Department in which he/she has undergone the B. Pharm semester course, in prove of his/her having regularly and satisfactory undergone the course of study by attending not less than 75% of the classes held both in theory and practical separately in each subjects shall be eligible for appearing in the B. Pharm semester examinations.

In case, a students is short of attendance due to illness, participation in sports, extra curricular activities etc. (after getting the supported evidences/certificate from academic authories) the following rules shall apply

- a. Shortage of upto 10% shall be condoned by the HOD on the specific recommendations of the class teacher.
- b. Shortage of upto 25% can be condoned by the VC on the specific recommendations of the HOD. Student will be allowed to go for training in Institution all over India with due permission from the HOD.
- c. In case of married women students who have granted maternity leaves in calculating the total no. lecturers delivered in the Institute for her course of study in concerned semester, the No. of lecturers in each subjects delivered during the period of her maternity leave (not exceeding three months) shall not be taken into account.

A candidate had attended such no. of lecturers and practicals by way of work in the institute, as may be prescribed by the concerned lecturers/readers, and HOD. But any shortage in practicals may be made up even after the final examination but the degree shall not be awarded until such shortage has been made-up.

The HOD of the institute shall have power to strike off the name of the student who is grossly irregular in attendance in spite of warning, or when the absence of the student is for such a long period that he/she cannot put in requisite percentage of attendance.

## 7. Eligibility for next semester:

All candidates who have appeared for all the subjects and passed the semester examination are eligible for promotion to next semester. A candidate who fails to appear or pass the sem-I examination may appear again in the subject (s) failed alongwith Sem-II examination,

A candidate who fails to appear or pass the sem —II examination may appear again in the subject(s) failed alongwith sem—II examination, provided one has passed the sem—I examination,

A candidate who fails to appear or pass the sem –III examination may appear again in the subject(s) failed along with sem –IV examination, provided one has passed the sem II examination.

The above said conditions are applicable for the higher semester also:

## 8. Mode of examination:

- Each theory and practical examination in the subject mentioned in table no. 1 to 8 shall be of three and four hrs. duration, respectively.
- A candidate who fails in the theory and practical examination shall be reappear both in theory and practical of the same subject with next semester.
